

# POSITION ANNOUNCEMENT Skilled Trades Helper

(Part-Time, Extra-Help Position, All Campuses)

The part-time Skilled Trades Helper assists the Skilled Trades Foreman with campus maintenance and repairs, including basic HVAC, plumbing, electrical, building upkeep, and preventative maintenance. This physically active role requires working safely in indoor and outdoor environments and may involve lifting to 50 lbs., climbing, crawling, prolonged standing, and equipment/tool use. This part-time role offers an opportunity for growth and may lead to a full-time position based on campus needs and strong job performance.

## RESPONSIBILITIES

- Assist Skilled Trades Foreman with general maintenance, repair, and facility tasks
- Support routine preventative maintenance projects
- Perform manual labor such as lifting, carrying, moving equipment, and grounds support
- Work in a variety of physical environments including heights, confined spaces, and outdoors in all weather conditions
- Use basic hand and power tools safely and correctly

- Possess a valid driver's license
- Ability to read manuals
- Must have own tools
- Travel between campuses
- Familiarity with equipment operation (trailers, tractors, lifts, backhoe) a plus
