**DOCUMENTATION IS NEEDED FOR EACH SEMESTER ENROLLED**

Act 1180 of 1999 allows McCurtain County, Bowie County and Cass County residents to enroll and receive the out-of-state tuition waiver at UA Cossatot.

In order for UA Cossatot to be eligible for a tuition adjustment, we ask those residents of McCurtain, Bowie and Cass counties to provide these documents.

1. Proof of residence in another state or parish which is adjacent to an Arkansas county in which a public institution of higher education is located, AND
2. Documentation (W-2 form or copy of Arkansas income tax form as filled) or receipt of wages from an Arkansas employer of minimum of \$5,500.00 in the tax year preceding enrollment, OR
3. Official verification from an Arkansas employer or current employment at a minimum of current year salary of \$5,500.00

Documentation that the students is a dependent of a nonresident Arkansas income taxpayer, which provides documentation satisfying the conditions of paragraphs (1) and either (2) OR (3) above.

**Waiver does not apply towards online courses.**

The Federal Cost of Attendance (COA) method shall be used for all students receiving UA Cossatot Waivers, regardless of whether the student is receiving federal financial aid.

If total financial aid funds exceed the COA, UA Cossatot will reduce or eliminate institutional funds.

Students receiving UA Cossatot waivers must be meeting Federal Financial Aid Satisfactory Academic Progress. Please refer to student handbook and CCCUA website.

If student is receiving financial aid that is tuition specific, UA Cossatot will reduce or cancel UA Cossatot waiver.
